

**IN THE MATTER AMENDING PROFESSIONAL SERVICES AGREEMENT WITH

NOW IT IS RESOLVED, said contract OLDF12312021FCJC with Karyn Oldfield and Franklin County is hereby amended as follows to wit:

PARAGRAPH 12(g) shall be amended to include: Attorney shall also receive compensation of \$200 per month to include the bi-weekly rotation of handling first appearance matters for pending civil cases.
