



## IN THE MATTER AMENDING PROFESSIONAL SERVICES AGREEMENT WITH ATTORNEY HEATHER VILLANI TO PROVIDE PUBLIC DEFENSE SERVICES IN FRANKLIN COUNTY JUVENILE COURT

**WHEREAS**, Franklin County entered into a Professional Services Agreement with Heather Villani per Resolution 2018-175; and

**NOW IT IS RESOLVED**, said contract VILLA12312021FCJC with Heather Villani and Franklin County is hereby amended as follows to wit:

PARAGRAPH 12(g) shall be amended to include: Attorney shall also receive compensation of \$200 per month to include the bi-weekly rotation of handling first appearance matters for pending civil cases.
