2021 Request for Materials Bid: Striping Paint and Materials

Franklin County is requesting bids from qualified suppliers interested in supplying and delivering traffic marking paint and materials to be used in County Road maintenance.

The following Instructions to Bidders, Specifications, and Bid Proposal are for materials to be used by the Franklin County Public Works Department.

INSTRUCTIONS TO BIDDERS

1. These instructions to bidders are a part of the specifications.
2. The County must be notified at least one (1) week prior to bid opening time of any revisions the bidder suggests be made to the detailed specifications. All requests for changes must be submitted in writing. Any changes, additions or deletions to the specifications by the County will be made by written addendum only.
3. Bids will be considered final at the time and date stated for opening bids. The County will not accept any changes for any reason, including bidding errors.
4. Use of the enclosed bid proposal is required. Only bids submitted on the official form will be considered. The bid shall not contain any unauthorized additions, deletions, alternate bids or conditions.
5. Bidders shall complete all items on the Bid Proposal. Incomplete Proposals will not be accepted.
6. Price for material delivered shall be FOB Franklin County Public Works, 3414 Stearman Avenue, Pasco Washington. Deliveries will only be accepted between 7:30 AM and 4:00 PM Monday through Thursday, excluding holidays. The cost of freight shall be included in the unit price of the material unless indicated otherwise on the proposal form.
7. Estimated quantities of each color assumes the material will be delivered as follows:

Waterborne Marking Paint – Delivered in poly totes filled with 250 gallons of paint

If the manufacturer's tote capacity varies from this amount, a partial tote may be required in order to meet the required delivered quantity. Final delivered quantities shall not vary

from the quantities listed on the bid proposal unless prior written approval is given. Payment will be made on the basis of actual quantities of each item delivered, except that unapproved quantities in excess of the bid proposal quantities shall not be measured or paid for.

8. The successful bidder shall protect, defend, indemnify, and hold the County, its agents, employees, officials, and officers harmless from any damages, costs, or liability for any injuries to persons or property arising from acts or omissions of the bidder, bidder's employees, agents, or subcontractors, howsoever caused.
9. The bidder shall not discriminate against any client, employee, or applicant for employment and services on the grounds of race, creed, color, national origin, sex, marital status, age, or presence of any sensory, mental, or physical handicap, unless based upon a bona fide occupational qualification.
10. The bid shall be placed in a sealed envelope marked on the outside "SEALED BID- 2021 TRAFFIC MARKING PAINT" and may be mailed or hand delivered (by appointment) to the Franklin County Public Works Department, 3416 Stearman Avenue, Pasco, Washington, 99301. Bids must be received prior to 10:00 AM on Thursday May 20th, 2021. Bids received after that time and date will not be considered.
11. Bids shall be opened and publicly read aloud after 10:00 AM at the Public Works Department on Thursday May 20th, 2021. A conference call will be set up to offer bidders the opportunity to hear the bid results.
12. The low bidder will be determined based on the total base bid amount. If a discrepancy exists between the price per unit and the extended amount of any Bid item, the price per unit will control.
13. Franklin County reserves the right to accept or reject any or all bids submitted. The County reserves the right to waive any irregularity in the bids to accept in whole or in part such bid or bids as may be deemed in the best interest of the County.
14. The venue and jurisdiction of any actions of claim for or against the bidder or the Franklin County Public Works Department shall be in Franklin County and in the District Court or Superior Courts thereof according to the jurisdictional amount.
15. It is the intent of Franklin County to purchase an approximate total of 3,750 gallons of Yellow Marking Paint, 3,250 gallons of White Marking Paint and 50,400 pounds of Glass Beads.

SPECIFICATIONS

General

Paint shall be free from foreign materials such as dirt, sand, fibers from bags, or other materials that can clog screens, valves, pumps, or equipment used in striping. Paint shall show no evidence of excessive caking, settling, separation, livering, skinning, or corroding of the container upon storage in the bulk tanks or in the sealed container as received. Paint shall be capable of being applied with the striping equipment (airless system) to give a smooth uniform stripe without the following problems:

- a. Paint skinning and splattering
- b. Excessive pressure and gun adjustments
- c. Excessive dusting or fogging
- d. Excessive temperature adjustments

Paint lots that continue to require equipment cleanup and adjustments will be field rejected and shall be replaced at no additional cost to the County.

Waterborne Traffic Marking Paint

Waterborne traffic marking paint shall meet the specifications of Section 9-34.2(5) as set forth in the current Edition of Washington State Department of Transportation Standard Specifications for Road, Bridge, and Municipal Construction.

Glass Beads for Pavement Marking Materials

Glass beads for pavement marking materials shall meet the specifications of Section 9-34.4 as set forth in the current Edition of Washington State Department of Transportation Standard Specifications for Road, Bridge, and Municipal Construction.
